**RE: 2017 MEDICAL MALPRACTICE / PROFESSIONAL INDEMNITY FOR PSYSSA MEMBERS**

As Medical Malpractice / Professional Indemnity covers is mandatory for all professional Psychologists, please see the terms and conditions below, offered by FNB Insurance Brokers, the Policy is underwritten by Hollard Insurance Company (Pty) Ltd.

“All registered psychologist, must obtain professional indemnity cover, which must be fully maintained at all times” as per the Health Professional Act 56 of 1974.

Cover commences from 1 January to 31 December.

**The Professional Indemnity cover options are as follows:**

Deductible: R1,000.00 Each and Every Claim



**Extensions applicable in the aggregate, and forms part of the Limit of Indemnity:**

- Statutory Defense Costs: R250 000 per claim/per policy period (under Public Liability option)
- Wrongful Arrest: R250 000 per claim/per policy period (under Public Liability option)
- Defamation: R100 000 per claim/per policy period
- HPCSA / Other Statutory Body Civil Defense Costs: R250 000 per claim/per policy period
- Excess is R2,500 each and every claim
- Additional reporting period / Run-Off Cover for 36 months (**PsySSA Members Only**)

In order for the Insurance Certificate to be issued, the attached proposal form needs to be completed and returned to FNB Insurance Brokers together with your proof of payment.

Your Certificate will be issued on receipt of your fully completed proposal form, proof of 2017 PsySSA membership and proof of payment. No insurance certificate will be issued without all these documents received by FNB Insurance Brokers.

We endeavor to send out the renewal notices by the end of November each year, it however remains the responsibility of the client to ensure that we receive your completed proposal and payment before the certificate expires on the 31 December.
