PsySSA Annual Awards

Award for Science

This prize is awarded in recognition of a significant contribution to psychological science by a current or past scholar or team of scholars.

Eligibility

- ✓ At least a Master's qualification
- ✓ Working in practice, academia, consulting or the world of work
- ✓ Significant scientific contribution to psychology
- ✓ The publication of at least 5 peer reviewed articles
- ✓ Must have obtained at least 1 grant for research

Assessment criteria

The nominee's contribution to psychology should be visible through excellent research, refereed publications, success in securing research grants and the national and international visibility of his/her/their profile and projects.

The nomination form below should be submitted with a letter of support detailing: The nature of the nominee's work, specifying the contribution to psychological science by:

- (a) Describing the important theoretical and empirical contributions and their impact on the field that are usually attributed to the nominee
- (b) Comparing the nominee with others in her/his field.

Additional documents required

- Curriculum Vitae of the nominee
- Letters of support from at least two scholars familiar with the nominee's work
- A list of the nominee's five most significant publications
- Five reprints of the nominee's representative work (preferably in electronic format)
- · PsySSA membership of participant optional

Judging body and process

- A jury will evaluate nominations.
- Nominations close on 30 June 2018.
- The selection will be made at least two weeks before the PsySSA Congress.
