## **Award for Mentoring and Development**

## **Eligibility**

- ✓ At least a Master's qualification
- ✓ Working in practice, academia, consulting or the world of work

#### Assessment criteria

Contribution to psychology should be visible through a demonstrable, excellent track record in mentorship and development.

The nomination form below should be submitted with a letter of support detailing: The nature of the nominee's work, specifying the contribution to mentorship and development in psychology by:

- (a) How the mentor transformed, guided inspired someone's career path, i.e. describe the process and impact of the mentor's guidance on specific persons and/or groups.
- (b) How the mentor influenced a larger group of students, colleagues and/or scientists leading an organization, institution, project or through lecturing/ seminars/workshops
- (c) Highlighting an established record of involvement with students, interns, colleagues and related persons.

## **Additional documents required**

- CV of the nominee
- · Letters of support from at least two mentees
- List of post-Masters mentees with a very brief (i.e. one paragraph, not more than one third of a page) description of their accomplishments

#### Judging body and process

- · A jury will evaluate nominations.
- Nominations close on 30 June 2018.
- The selection will be made at least one month before the PsySSA Congress.
