Marise Ph. Born is Full Professor of Personnel Psychology at the Institute of Psychology of the Erasmus University Rotterdam. She also is Endowed Professor of Industrial and Personnel Psychology at VU University Amsterdam. Her research interests are in the domains of personnel selection, cross-cultural psychology, test development, and personality and individual differences. For many years, she was active as council member of the International Test Commission (ITC), of which she was President from 2008-2010. Between 2009 and 2015 she was Chair of the EUR Institute of Psychology at the EUR., she is chair of the NSVP (Dutch Foundation for Psychotechnics, www.nsvp.nl) and for many years she was member of the COTAN, the Committee of Testing Affairs of the Dutch Institute for Psychologists NIP. She was part of the task force of ISO 10667, a world-wide ISO

Standard on assessment of people for work-related purposes launched in 2010 (www.iso.org).
