### Award for the World of Work

This prize is awarded to an individual who has developed, refined, and implemented practices, procedures, policies and methods that have impacted on both people in work settings and the profession of psychology.

#### Eligibility

- ✓ At least a Master's qualification
- ✓ Registered as a psychologist at HPCSA
- ✓ No disciplinary actions against practicing record
- ✓ Should have been in industry/world of work for at least 5 years
- ✓ Impact of work as a psychologist should be visible in terms of research, publications and/or testimony of participants.

#### Assessment criteria

Contribution to psychology should be visible through demonstrable record of excellence in the world of work as outlined below.

**The nomination form below should be submitted with letters of support detailing:  
The nature of the nominee's work, specifying the contribution to psychology in  
the world of work by:**

- The development of practices, policies, procedures, and methods and/or
- The implementation and or enforcement of practices, policies, procedures, and methods
- The impact on the world of work through any other means.

#### Additional documents required

- CV of the nominee
- Provide evidence or documentation that is available to support the contributions of the nominee. Nominators should provide more than testimonials about the impact of a nominee's professional contributions.
- Letters of support from at least two persons impacted by the practitioner

#### Judging body and process

- A jury will evaluate nominations.
- Nominations close on 16 August 2024
- The selection will be made at least two weeks before the PsySSA Congress.
